It is Revo Testing Technologies's policy to respect your privacy regarding any information we may collect while operating our website. This Privacy Policy applies to revotestingtechnologies.com (hereinafter, "us", "we", or "revotestingtechnologies.com"). We respect your privacy and are committed to protecting personally identifiable information you may provide us through the Website.
